Linda turned the meeting over to Bob Nemeth, Kinsman Park Committee Chairman. He described the purpose of the Park Committee is to develop the Old High School property, and said that the committee has been meeting since February, 2018. He told the trustees that Bart Gilmore has created a tentative drawing of plans for the Kinsman Green Space, and thanked him for the many hours he donated to create the drawings. The property had to be surveyed. There were no funds expended to pay for the survey, since donors paid for it in total. The survey will be filed in the courthouse. It is suggested by the committee that 0.1159 acres to be split off and deeded to the Kinsman Public Library.

Bob explained that \$2700 was raised from the community to pay for the survey. There is a special fund set up with the township to receive and pay expenses that are associated with the Park Committee. There are plans for an amphitheater, basketball court, walking path, and dedicated space for the circus and car show. An additional generous \$7000 was received by an anonymous donor recently.

Bonnie Mathews keeps records of the minutes and they are available to anyone interested.

Greg thanked the members of the Park Committee and Bart Gilmore for all he has done for the committee, Aaron Meardith for his work with aerial photos, and WaterStone for their generous donation. Bob told the trustees that there are many local volunteers that are willing to work to do park projects.

Jeff Mathews, a member of the park committee, told the trustees that the park plans can be done in stages, according to our budget.

Greg received a call from Jason Jewett regarding his Eagle Scout project.

- 3. A meeting to discuss the ambulance contract for 2019 with Johnston Township and Ambulance committee on January 22 at 7 p.m. at the Johnston Fire Department.
- 4. The trustees will be meeting with Kinsman Township Department heads on Saturday with Zoning, Fire, and Road.
- 5. Linda said that usually Greg is in charge of LTIP/SCIP with Fred working with the Park. Linda works with EMA and Army Corps of Engineers. They will continue as in the past.

6. Linda explained that the Council of Government is a consortium of public entities with tiers based on population. Kinsman is in the lowest tier. Their biggest concern is infrastructure. If they would place a 0.25% additional sales tax in Trumbull County, then based on our population, we would stand to make \$76,000. All of this will be worked out with the COG Board meeting. Linda said that if we could save two years' worth of that money, we could then do OPWC projects, which are a bigger budget. Borrowing or lending equipment is also on the agenda of discussion with the COG. Group rates for health insurance, maintenance done through the county for our vehicles, and purchasing our parts would give us a greater discount because of the larger group rates.

New Business:

- 1. Greg asked Marge about HB 291, which has to do with bonding of officials and police officers. Marge will contact OTARMA to find out the details.
- 2. Fred was contacted by a resident who asked about parking at the park while he hunted. As long as he is not hunting on township property and is following the no parking dusk to dawn rule, he is allowed.
- 3. Road- Tim called Tom Klejka to ask if the county can do chip and seal on some roads in Farmdale while they are working near the bridge on Burnett East Road. He also would like to have Delin Thomas Road repaired from where the Issue II project leaves off up to Kinsman Nickerson. He called Bruce at Martuccio's and he did not have a price for him. He did lower his price last year when he learned what the county was quoting.
 - Tim told the trustees that Ward Christy and Turner Mullen are in bad condition. He has 222 ton of salt currently, and has another 200 on order so far. Salt prices are good.
- 4. Zoning- Mark read his report to the trustees. A copy of his report can be obtained by contacting the Fiscal Officer.
 - He did receive an answer from the Planning Commission. He will be presenting that to the Zoning Board at their meeting on Monday night. He received a notice from Pipeline Safety as to their regulations, and he receive notice from County Recorder Todd Latell reminding him to file any zoning changes with is office.
- 5. Fire- Cory has sent an order for safety equipment to be paid for with the BWC grant.
- 6. Police- Greg read the 2018 Year Police Report. A copy of the report can be obtained by contacting the Fiscal Officer.
- 7. Nothing to report from the Zoning Board.

Regular Meeting Held on January 28, 2019 at 6:00 P.M.

Chairman Greg Leonhard called the meeting to order. All elected officials were present, except for Linda Miller. There were twelve others present: Mark Posey, Susan Slater, Zane Stowe, Shawn Rentz, Melissa Rentz, Loren Hopkins, Bruce Bancroft, Steve Papalas, Ken Stafford, Angela Rogers, Marnie Minor, and Amerissa Minor.

Greg Leonhard asked that all present stand to recite the Pledge of Allegiance.

Greg Leonhard made a motion, seconded by Fred Stahl, to table the reading of the minutes of the January 14, 2018, meeting. The motion passed unanimously.

Correspondence: There was no correspondence.

Officer Shawn Rentz introduced Officer Zane Stowe, who was sworn in as Reserve Officer by the Fiscal Officer.

Old Business:

- 1. The Zoning Board set their hearing to discuss the Dollar General project and proposed zoning change for February 21, 2019, at 6 p.m. at the Kinsman Administration Building.
- 2. The trustees and ambulance group will be meeting to learn about Fire/EMS district creation on February 6, 2019, at 7 p.m. at the Johnston Fire Department.
- 3. A meeting for the Pymatuning Creek Advisory Committee will be held at the Kinsman Administration Building at 7 p.m. on February 7, 2019. They are looking to create a 10-person committee.
- 4. Greg said we have a road levy up for renewal or replacement this year. He is working with Fred to create a map of township roads and county roads in Kinsman. He would like to have an Open House on April 27, 2019, from 10 a.m. to 2 p.m. at the township garage to discuss with the public road repair projects and educated the public on our Road Department, equipment, and personnel. The County Engineers will have representatives present, and Greg will reach out to ODOT to see if they can have a representative attend. Greg will have a van to bring the public to different roads that need attention so they can have a complete understanding of our township road condition and what it takes to repair them.
- 5. The Park Committee was represented at the reorganization meeting. The township moved to turn over 0.1159 acres over to the Kinsman Public Library.
- 6. Fred told the public that we met with the ambulance group of Johnston Township, as well as trustees that have contracts with Johnston for their ambulance service. The ambulance

group is expecting to be at a deficit at the end of the year. That prompted the upcoming meeting to discuss learning more about a district. Pay for EMTs is currently \$10 per hour, and Paramedics is currently \$11.15 per hour.

New Business:

1. Greg received a complaint from a resident on Willcrest Road not having been plowed. It is about 300 to 400 yards in length. The County Engineer's office sent Greg a reply that Willcrest is a private drive, and that Kinsman Township is not paid for road mileage to maintain this stretch. Greg would like to research the cost of adopting it into a roadway.
