2. Zoning- Mark gave the trustees his monthly statistics. The State Route 7 60-Mile Yard Sale will be held August 30th, Sept 1st, and Sept 2nd.
3. Fire- Tyler gave the trustees his monthly report. The helmets are in. He is working on a Firehouse Sub grant, State Farm grant, and a Norfolk Southern grant. He is working on policies. Travis Sapp has resigned from the department. The tanker has had repairs. Tyler told the trustees that the Knox Box at the library worked well after the

fire alarm went off. They have had discussion regarding their new building. Bruce will attend the August 13th meeting.

- 4. Police- They are going to cite the person who was illegally dumping at the recycling area. Discussion was had regarding the new police vehicle and capital lease information.
