- 2. The trustees have received a resume for a full-time Road Worker application. The trustees feel that they can make do with an additional worker to snow plow, then advertise for a full-time Road Worker in the Spring.
- 3. Fire Department Lease:

[RN2024-133] Jamin Banning made a motion, seconded by Greg Leonhard, to rescind resolution number RN2024-120, a lease agreement with Kinsman Volunteer Fire Department, Inc. which was to house Kinsman police vehicles, due to the discovery of costs being too high. The Kinsman Volunteer Fire Department, Inc. will look into quotes to rework their current building that could be possibly be used to house police vehicles.

New Business:

- 1. Greg told the trustees that he has been receiving many complaints of noise and barking dogs. He talked with legal counsel and Officer Jordan Hefner reached out to the Prosecutor's office. Greg asked the trustees about adopting a resolution per ORC 504.04 and 715.40. The trustees discussed provisions in the noise resolution, which would provide fines for loud and raucous noise before 7 a.m. and after 10 p.m., as well as exemptions for township residents. The trustees would like to add some things to the resolution such as farmers' working agricultural, guard dogs that don't bark for prolonged times, and gunshots for hunters which would likely be subject to time restrictions. Optimally, an offense would be witnessed by an officer to be held in violation. Jamin suggested we will work on language with legal counsel and read it the next meeting.
- 2. Greg said the Geauga Trumbull Solid Waste Grant is opening. If anyone knows of a senior citizen who would like to receive a lunch on Christmas Eve, please let us know to add them to the list. About 8 seniors have passed away since last year. Greg has reached out to churches to ask and Rochelle is making flyers to put into bags for seniors already listed.
- 3. Police-Thad read his monthly report for the trustees. A copy can be obtained by contacting the fiscal officer. The Tip a Cop fundraisers have reached a new record. Police and Fire worked together to raise \$6,106.28 this year. There are still donation buckets in three local stores that need to be brought in and counted. Thad said this year was amazing and thanked all those in the police and fire departments, as well as their families and others who waited tables for their success. He also thanked the patrons who donated so generously this year. There will be a total of 8 families with 15 children that will be able

to shop locally for Christmas. They will each be allowed to spend \$200 and return home with a dinner to cook for Christmas at home. Thad is working with the senior center, as well, to donate to seniors. Shop with a Cop will be held on December 12th and after shopping the children will return to the administration building for a pizza dinner. The Christmas Parade will be held on December 8th. Newly hired Officer Carr is now patrolling on his own. The cruiser will be done next week. Thad also thanked Friends of Kinsman who raised \$900 for Shop with a Cop, as well. The golf cart is running fine. Times Square was impressed with Officer Carr's table-waiting skills.

4. Fire-Tyler read the trustees his report. A copy can be obtained by contacting the fiscal officer. He is working on policies and reminded everyone there is a burn ban until the end of November. Air Packs have been serviced on November 22nd and fire trucks have been pump tested November 23rd. He will be taking National Incident Management classes in December and January. Tyler has shopped around for price quotes for repair of the rescue radiator.

Tyler told the trustees the Knox Box still needs to be sent off to repair.

He is applying for FEMA grants, both with a 5% match. He is going in on a regional grant hosted by Lordstown for hose. He does not know what the match will be yet. He is also attempting to write a grant for a new tanker. Tentative pricing should not be more than \$655,000 and 5% would be \$32,750. If the grant succeeds it will save the township \$622,250.

Tyler has been working with the American Red Cross on a Sound the Alarm Program that will provide smoke alarms to families who do not have them. This will be very beneficial to seniors, too. If anyone needs a smoke alarm please contact the Kinsman Volunteer Fire Department. Applications are available now through the fire department and will be available in more places as the program progresses.

- 5. The trustees received the 2025 Ambulance contract from Johnston Township. The rate has gone up about 40% for next year. Wayne, Williamsfield, and Cherry Valley all utilize Community Care in Andover. Tyler will check into meeting with them to get a quote. The trustees held off on signing with Johnston Township until they can meet with Community Care.
- 6. Road- Vince said the 550 is finished with repair. It now has a new Hydroboost, new master cylinder, new brake pads, and new hood cylinders. The 60" culvert on Morford has been installed by the county and waiting for ARPA monies to pay the county and materials supplier. The International needs a new battery. Vince met with Howland Alarm to get a quote on an alarm system at the garage. The quote was about \$1200 to secure the garage with a \$36.75 monthly contract fee. This will provide both security and smoke alarm protection for all the township equipment housed in the garage.
